#### LETTER FROM THE PRESIDENT AND THE EXECUTIVE DIRECTOR

# CANADA'S MOST EFFECTIVE ENVIRONMENTAL ACTION ORGANIZATION IS ANSWERING THE CALL OF DUTY.

When opportunity comes-a-knocking on the door of environmental change, who do you expect to answer the call?

When the federal government opts to review its weak cosmetic regulations, they need to be reminded of what's in the best interest of Canadians' health. When the petroleum industry works hard and fast to green its name while planning pipelines to carry its dirty oil to other countries, someone needs to tell the world how the tar sands are a scourge on our landscape and a detriment to locals' health and communities. This was a year for Canada's most effective environmental action organization to step up to the plate.

And step up we did.

This year, we pushed for (and won!) a long-overdue update to our consumer product safety standards. We worked with communities across Canada to promote clean water and environmental excellence on our beaches. We brought the message of Canada's dirty energy habit to the world. We tested Canadians' makeup bags for cancer-causing and otherwise harmful chemicals. We challenged governments to keep and build on important policies that protect our health and our green spaces. And, we celebrated when our chemical foe, bisphenol A, was finally declared a toxic substance by the Canadian government, which also happens to be the first nation in the world to do so.

Of course, if you know us at all, you know we won't rest now. Not while there are polluters, greenwashers, and stodgy resisters of change compromising Canadians' environment and human health. When opportunity knocks, we're up for the job, and we will keep counting on the support of individual Canadians, foundations, businesses, communities, lawyers, scientists, advocates and governments to help us do it. Because we want what all Canadians want: a world we are proud to pass onto our children.

#### Greening Ontario's Gravel Industry

We've lost some sleep over the vears about the potential impact of the construction industry on our land and water. We decided it was high time to take this issue on, so we partnered with Holcim Canada to create SERA (Socially and Environmentally Responsible Aggregate) Canada. By drafting standards for aggregate siting, rehabilitation, operation and use, our hope is to create a certification that Ontario's gravel industry can strive to meet. We've taken the first step on an important road to greening this resource.

# Young Canadians Take the Cake

Canada's young talent took the cake again this year in the International Young Reporters for the Environment competition, Liz Welliver beat out entries from 15 other countries to win the contest's biodiversity category. Her article, "Making a Stand for Avatar," captures the attempts to preserve a newfound swath of ancient old growth forests in B.C. "This win speaks not only to the outstanding quality of submissions that we received this year, but more largely to the importance that the environment holds with Canada's vouth." said Sarah Winterton, Strategic Partnerships Director and YRE administrator. "We're thrilled to see one of our own being



recognized on the international journalism stage and we wish to extend congratulations to all of the 2011 winners."

We know we're not featherweights in the fight for safer cosmetics and better labelling, but we're glad to have them in our corner.



# Our Little Greenbelt is Growing Big and Strong

You know how kids seem to grow big and strong right before your eyes? Well, Ontario's Greenbelt is doing the same. In December, the Ontario Greenbelt Alliance announced that six proposals to expand the Greenbelt had received approval from municipal councils or committees. The proposals demonstrate the continued support for the Greenbelt, now in its fifth year, among Ontarians. Toronto, Mississauga, Brampton, Guelph, Hamilton and Oakville are municipalities working on requests that will ask the Province to expand the Greenbelt into their communities. Now, it's time to pinch the Greenbelt's cheeks and tell it how proud we are.

# Protecting Important Landscapes

Since 1985, we've been working to protect the rural features and natural heritage systems that are home to our most precious farmland and threatened species, and we're still leading the way. This year, the forest of Boyd Park was finally put off limits to a new highway with the dedication of the Pierre and Janet Burton Trail, an ENVIRON-MENTAL DEFENCE and *Friends of Boyd Park* project stretching back almost ten years.

We're also fighting significant guarry battles to protect our precious Niagara Escarpment. One of our long-standing community partners in Caledon, the Coalition of Concerned Citizens. won an important victory to stop a below water table guarry. Now, we're working with partners Clearview Community Coalition and Grey Matters to battle proposals on the highest point of the Escarpment in Duntroon, Ontario, In another battle, we and our partners Protecting Escarpment Rural Land and Sarah Harmer are trying to ensure guarries never again threaten Mount Nemo. Canada's natural heritage advocate keeps on keepin' on!



We've long been making a stink about the environmental, economic and health catastrophe that is the Alberta tar sands, and, south of the border, our message is being heard loud and clear. This year, the tar sands saw increased attention from the United States.

In September, one of the top officials in the U.S. government, Nancy Pelosi, requested a private meeting with ENVIRONMENTAL DEFENCE and a few others to discuss Canada's oil sands. The purpose of her visit was to "learn and listen at a time where the debate in Canada continues over oil sands and the future of energy security in North America."

More recently, we were invited to meet with U.S. decision makers in Washington. This meeting raised concerns about the failure of the draft environmental review to look at the impact of the pipeline on tar sands pollution in Canada. The following morning, the U.S. Environmental Protection Agency released their comments on the State Department's draft review, calling it "insufficient" and referred specifically to the need to have a detailed discussion about what companies and governments in Canada are doing to reduce emissions from tar sands. Clearly, the EPA is pointing a finger at Canada's emissions issues and is looking for answers from our government.

We were also honoured to host John Podesta, former chief of staff to U.S. President Clinton, and head of the *Center for American Progress*. Mr. Podesta delivered a powerful wake-up call: The rest of the world is embracing renewable energy in a big way. The United States, Europe and especially China are competing globally for a piece of an estimated \$2.3 trillion renewable energy industry. This is not an opportunity that we can afford to miss. He commended Ontario for positioning itself as a global leader with its Green Energy Act, pointing out that our Feed-In-Tariff (FIT) "has put Ontario on the map not just as a leader in Canada but as a model for the world." He cautioned us not to give in to those who want to preserve the status quo, or worse, take us backward.



"There is a big market for green energy here in Ontario. Some 40 manufacturing firms have announced their intentions to open facilities here in Ontario and more than half of them are already in production, creating thousands of good jobs for Ontario workers. This is living proof that we don't have to trade off jobs and a clean environment – we can have both. And in this climate of economic and environmental uncertainty, it's really great news."

We couldn't agree more. We continue to work with United Steelworkers (USW) on Blue Green Canada to promote Ontario's transition to a green economy and the good, green jobs it creates. In November, ENVIRONMENTAL DEFENCE marked the first year of Ontario's *Green Energy & Green Economy Act*, with a report that examined some of its stories and successes. *Faces of Transformation: Jobs, economic renewal and cleaner air from Year One of Ontario's Green Energy Act* underlined how clean energy is rejuvenating the province's economy and helping to close polluting coal plants.

The report found that Ontario has offered contracts for more wind and solar power than France in the first year of its program and more solar than Spain in its first year. It's not just about winning the global clean energy race, though. More than 35,000 people have applied for renewable energy installations, and thousands of Ontarians have found work manufacturing green energy technologies. That's good news for Ontarians, our economy, and for the air we breathe.

When you're putting on lipstick, brushing your teeth, or smearing diaper cream on your baby's bottom, are you thinking of ENVIRONMENTAL DEFENCE? We'd like to think we're with you in the bathroom in the mornings. Okay, it's not what it sounds like. What we mean is that we've been working tirelessly on behalf of Canadians to get the toxins out of your personal care products, toys, household items, and the stuff your family uses every day.

Since 2006, we've been testing Canadians' bodies for dangerous and bioaccumulative chemicals that shouldn't be in there. Our bestselling book, *Slow Death by Rubber Duck: How the Toxic Chemistry of Everyday Life Affects Our Health*, has opened eyes across Canada, the U.S., Australia, South Korea, and China to the pollution in our bodies from the products we use and the spaces we live in. And, our work with Canadians to get bisphenol A (BPA) out of baby bottles resulted in a law being passed in 2008, and started a flurry of political activity around the world to protect people from this nasty chemical.

And this year has been a big one for our continuing efforts.

This spring, we released a report, Heavy Metal Hazard: The Health Risks of Hidden Heavy Metals in Face Makeup, that caused alarm the world over about the nasty stuff in our makeup. We sent six Canadian women's makeup bags to the lab, and 100% of the 49 products tested contained toxic heavy metals, such as lead, arsenic, and cadmium. What's worse, none of these metals were listed as ingredients in the products, since they're what Health Canada calls "impurities", or unintentional contaminants. This report was our most read report ever. It got press coverage from as far away as Hong Kong and as near as almost every major news outlet in Canada. And, it practically turned twitter upside down! Here's hoping that all this attention leads to a change to Canada's weak regulation of impurities in cosmetics.

Change did come in a battle we've been fighting for years, though. In October, Canadians saw BPA officially added to the Toxic Substances List. This announcement represents not only another defeat for the hormone disrupting, reproductive damaging substance (and industry, who've fought hard to keep this bad guy in business), but it's another notch on Canada's belt for leadership in toxics reduction. Speaking of leaders, guess who has been leading the charge to ban the chemical in food and beverage containers for the past five years? Yep, that's us.

We also led the effort, along with our partners in the Canadian Consumer Specialty Products Association, in updating Canada's 40-year-old product safety legislation. After two long years, and three times through the House of Commons, the Canadian Consumer Product Safety Act finally passed in November, catching Canada up to the United States and Europe for laws of this kind. Prior to this new legislation, our government did not have the capacity to make mandatory product recalls or order product safety tests, leaving these measures in the hands of companies.

Of course, this is all a lot to think about when you're brushing your teeth. But, safer products means you have one less thing to worry about when you're shopping, cleaning, or primping: your family's safety.



When you're a Canadian, you have to make the most of a short summer. So, when you're graced with one of our few hot summer days, all you want to do is slip into your water wings and hop into the nearest body of water (with the right technique, you might even be followed by a giant splash). When you're slipping and splashing and cooling off, you want to know that the water you're splashing in is clean and safe.

ENVIRONMENTAL DEFENCE has your back. As the coordinator of the *Blue Flag* program in Canada, we work with communities to ensure our beaches have the best water quality, environmental education, environmental management, and safety and services.

Last year, we boasted about 15 Canadian beaches and three marinas flying the flag. But this year, we're really giving beachgoers something to talk about. In 2011, 19 beaches raised a *Blue Flag*, and three beaches have achieved candidate status. And, there are communities from east to west coast working to meet the criteria and get their hands on a flag for next season.


This is the year that *Blue Flag* has grown from a niche to a national program. The level of interest and the engagement from communities has been nothing short of inspirational. We're so proud to work with so many communities to ensure Canadians beaches and coastlines are clean and safe.

Thank you to **RBC Foundation** and **Barefoot Wine** for supporting the national *Blue Flag* Program. Each beach flying the *Blue Flag* has met specific criteria for water quality, environmental management, education, safety, services and accessibility. With support from the **RBC Blue Water Project**, and the **Barefoot Beach clean-up days**, the program is growing with *Blue Flag* beaches in five provinces next year. Thank you for ensuring Canadians have access to clean, swimmable beaches and marinas.


#### **GRIT HAPPENS**
